**Collection, Use and Disclosure of Information:**

In consideration of the **Inquirer's** acceptance, you expressly consent to and authorize the following:

1. **The Inquirer** may obtain Information about you through a credit bureau report conducted by **Rent Check Credit Bureau** and as permitted or required by law. You expressly authorize **Rent Check Credit Bureau** to provide Credit Information regarding you to **The Inquirer**.
2. **The Inquirer** may use Information about you to determine your suitability as an employee and as permitted or required by law.
3. **The Inquirer** may disclose Credit Information about you to **Rent Check Credit Bureau**, as permitted or required by law, for inclusion within a database of credit information and within a credit file on you, for purposes of:
  - Credit reporting in accordance with provincial credit and consumer reporting acts;

Negative Credit Information shall be maintained on record in accordance with provincial credit and consumer reporting acts.
